2. Name of District Grant: Heart Surgery for Children
3. Briefly describe the grant and list any changes that might have occurred (100 words or less.)  
*Our club partnered with District 3240 and a Club in Australia to fund pediatric cardiac surgeries at an Indian where our member Dr. Bhauddin trained. He was given the opportunity to send 5 children with congenital heart defects from Afghanistan/Pakistan. The \$8,000 district was to fund Transportation and incidental expenses. In this period we worked to identify suitable candidates – their health, ability to obtain passports, visas, suitable guardianships, etc. Our first candidate for this surgery passed away during her recovery in India and her body had to be transported back to Afghanistan. We are currently seeking our second candidate.*
4. Provide a brief description of lessons learned in implementing this grant and how this will improve future grant funded projects.  
*We will need to consider the risks of unsuccessful surgery and the added costs for transporting and storage of a dead child.*
