Project Title: Wheel Chair Mounting Ramp

Project Description:

1. Briefly describe the project. What was done and where did the project activities take place?
Who were the beneficiaries?

Our project was to provide a ramp to Horsebuds Therapeutic Riding Center so that their wheelchair bound clients could get up to the platform and mount the horse. This ramp was purchased from Handi-Ramp and when it arrived, the members of Redeye Rotary spent an afternoon assembling the ramp. There was actually a wheelchair bound person there that day and when we were finished she rode her chair to the platform where she could have mounted a horse. Horsebuds is located approximately five miles north of Greeley and the ramp was assembled on site. The beneficiaries of this project will be the participants at the Horsebuds Therapeutic Riding Center who need assistance mounting the horses. The center has several autistic clients who do not like to be touched and they can also walk up the ramp and get on the horse without as much assistance. Also the Center has started a program for disabled veterans who will be using the ramp to mount from their wheelchairs.

There were 15 who participated in the assembling of the ramp and 3 who shopped and purchased and delivered the Kitty-up stirrups, the helmets, bench, weed barrier that will be used in a Sunflower Garden this summer for the participants to work in and enjoy, 3-step mounting block for assistance getting on the horses by those who do not need the ramp.

It is impossible to put a number to this question as there are present clients and future clients who will use the ramp. This ramp is also portable so it will be transported to Special Olympic events that will support more people.

This project will be used by the special needs community for years to come. The ramp is metal so it will last many years.
