Dear Ms. Scarpinato:

We are pleased to inform you that BHHS Legacy Foundation (the "Foundation") has recently approved a C.A.R.E. grant in the amount of \$12,000 for Kitchen on the Street to support its Bags of Hope program (the "Program") as detailed in your March 2, 2018 Letter of Inquiry to the Foundation.

The C.A.R.E. grant program identifies nonprofit organizations that provide urgent basic health care, supplies, food, shelter, transportation, and health-related support services to low income families, including the homeless. We hope this grant funding will assist Kitchen on the Street Inc. in fulfilling its mission by serving those in need in the community. No principal/agent, partnership, or joint venture relationship is created by the grant funding or otherwise nor should any be implied in the news releases or otherwise.

Your acceptance of this grant and this letter of understanding will constitute your agreement that the Foundation may make disclosure of the amount of the grant and the identity of your organization as the recipient if the Foundation elects to do so.

None of the grant funding may be used for any private benefit, political campaign, or carrying on propaganda or otherwise attempting to influence legislation.
