Project Title: Schroeder Park / Eagle River Town Square Park

Project Description

- 1. Describe the project. What was done, when, and where did project activities take place?
- At Eagle River Town Square Park we replaced the aging kiosk panels with artistic metal panels depicting Alaska wildlife & footprints, replacing a diseased spruce tree in the Rotary planter with a new tree to be used at our annual tree lighting ceremony (scheduled for July 2017), repainting the Rotary planter where the existing paint has been chipping and peeling away over the last 20-25 years (end of June), preformed tree/shrub trimming to lift the canopy and remove branches overhanging the existing pavilion, replacing several diseased spruce trees around the park with deciduous and flowering trees (scheduled July/Aug 2017), saw cut concrete base around flag pole that has become a tripping hazard and backfill with soil and grass seed to level to surrounding area (scheduled July 2017).

15,000+ visit the park every year

 Families utilize this park frequently throughout the year as a gathering place for special events and outdoor play at the playground. This is a central location for our yearly Bear Paw Festival as well as the annual Christmas Tree Lighting Ceremony complete with Santa and his reindeer. The repairs and upgrades to the park provide these families with a safer environment to congregate as well as continuing the annual tree lighting. Maternal and child health, Community and economic development.

 Trimmed trees and shrubs to provide a safer environment for children to play and preserve the existing infrastructure, prepared areas for painting through sanding, chipping and power washing the large Rotary planter followed by painting surfaces.

 Chugiak/Eagle River Parks and Recreation provided a list of priority items that required attention as well as providing preferred/contracted pricing for the tree replacements. They also will be providing the saw cutting and soil/seed for the flag pole. They have also provided financial contributions towards the kiosk and contract negotiation with the artist.
