Due to that sponsorship, approximately fifteen hundred individuals from low-income households that have little-to-no insurance have received free dental work, vision screenings and other health exams. Mr. Tanakaya,

I have attached, the Brea Family Resource Center's request for funding for this year's health fair. As stated in the letter, a portion of the funds would be applied to purchase supplies for the dental clinic. This year's fair will feature local Brea dentists whom will be performing visual assessments. If a client needs to be seen further, the FRC will arrange for payment and scheduling through Brea Community Emergency Council. Another portion of funds will be used to purchase additional dental supplies and educational material for those in attendance.

I do have a question for you. You may have noticed that we asked for \$2,000 instead of \$3,000 this year. Although, the Rotary Club has sponsored the Dental Clinic portion of the health fair, we have given full fair sponsorship to the organization. With that in mind and if funds allowed, would be able to use the funds to purchase new banners for marketing purposes. We have some funds available for that, but we are trying to create a more wide-appeal in order to attract more participants. Please let me know what your thoughts are. If this might be possible, I'd like to resubmit the request for a higher amount and include those additional costs.
