Project Description:

1. Briefly describe the project. What was done and where did the project activities take place?
Who were the beneficiaries?

This project was a collaboration between Rotary, the Good Samaritan Mission, and the Teton County Treatment Court Program. It took place at the Mission. A participant of the Treatment Court Program needed a community service project to successfully graduate from the Program. He donated his skills and labor to remove the decking around the Mission, which was so old it nearly caught on fire from a cigarette ash. Also it was uneven and dangerous to walk on. He then installed new trax decking. Rotary ensured the project was in compliance with the Mission's Board of Directors, obtained approval from the Treatment Court, obtained necessary donations for the matching grant, and applied for this grant.


