Project Description

1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries? The City of Breckenridge desired to raise funds by means of grants from foundations, state government, and private institutions in order to construct a skateboard park in part of the Breckenridge City Park. The city manager asked that we consider partnering with them in this endeavor, so we provided initially \$1500, then an extra \$500, and applied for a matching grant from the district, which was granted. In addition to funds, Rotarians worked at laying rebar and constructing some structure for the foundation of the skateboard park.

2. How many Rotarians participated in the project? 12

3. What did they do? Please give at least two examples. Rotarian Andy McCuiston coordinated all activities with the city, set up the work date, and took pictures. Other Rotarians donated time and effort to construction of the foundation while others supported the work with refreshments.

4. How many non-Rotarians benefited from this project? 250

5. What are the expected long-term community impacts of the project?
In our small town it is estimated that some 250 or so youth will take advantage of the skateboard facility, keeping them occupied in physical activity and clean group fun. The walking community benefits by having skateboarders off of the concrete walking trail (where they are technically not allowed anyway). Others will gather to learn how to skateboard that otherwise would not have such an opportunity, while others will gather to observe and support their friends who are skateboarders. These are positive impacts that either directly or indirectly benefit a much larger community.

6. If a cooperating organization was involved, what was its role? The City of Breckenridge has (will, in the case of the projected grant matching funds) put the funds toward their goals, and coordinated the work day for the foundation as well as managing the larger project.
