The books will be distributed to families enrolled in the Northern Region Migrant Education Program at our upcoming Migrant Christmas Fiestas in December 2016.

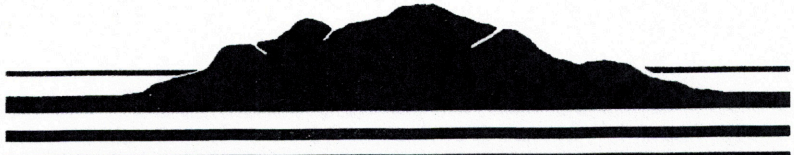
