Project Title: Dictionary and Literacy Project

Progress Report Final Report

1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

The First Phase of this Project – Dictionaries, **has been completed**. Rotarians, together with Interact Club Members, distribute paperback dictionaries to each of the Third Grade Students in Laguna Beach Elementary Schools. Actual distribution occurs at the schools in a small assembly of Third Grade Students, and took place in March 2017 at Top of the World Elementary; El Moro Elementary, St. Catherine's Elementary, and Annaliese's Willowbrook and Manzanita campuses. These Dictionaries are, in many cases, the first book the students own, and they are incorporated directly into the 3rd Grade curriculum by the teachers for daily in-class use by each student.

Second Phase – Fostering Literacy, is not yet complete – final expenditures will be made within the next 3 weeks. The Spot is a new program offering a safe and supervised after school study space for high school students to study and receive homework and academic assistance. Conceived by the Boys & Girls Club of Laguna for students who do not have a safe or supervised place to study after school, students are encouraged to come to The Spot, currently located in the Laguna High School Library. Interact Club Members attend to assist with homework and foster attendance. This project provides study aids and study program materials, snacks for students, and makes 'computer' tablets (iPads or ChromeBooks) available to the students for completing and submitting homework assignments (many students do not have computers at home or access to the internet to submit homework as required. Between 5 and 20 students visit The Spot per day.

2. How many Rotarians participated in the project? A total of 35 Rotarians were involved in the Dictionary distribution, and 10 Interact members participated in the elements of this First Phase of the project. Approximately 10 Rotarians have been involved in delivery of supplies to The Spot and in making trips to The Spot to assist and encourage the students in their studies. Approximately 10 Interact Club members are involved regularly.

3. What did they do? Please give at least two examples.

Dictionary Project: The Project Chair ordered, received and delivered 250 dictionaries to the Laguna Beach High Interact Club President. Approximately 20 members of the Interact Club applied Rotary Logo stickers to each of the dictionaries prior to distribution to the 3rd Graders at Laguna schools. Teams of 3-10 Rotarians and Interactors met at each Elementary School in Laguna Beach to distribute paperback dictionaries to each of the Third Grade Students. The Students were informed about Rotary's work and projects, internationally and locally, and were also told about the Laguna Beach High School Interact Club's battery collection and recycling program. Then a dictionary, marked with the Rotary logo, was personally presented to each of the 248 Third Graders in Laguna Beach.

Literacy Project: Laguna Rotarians purchased or assisted in the purchase of supplies and computer equipment for the Spot, and coordinated with the B&G Club representative for additional purchases and availability to assist at the Spot with supervision and encouraging student attendance and good study habits. Interact Club members attend daily to provide homework and study assistance for students requesting assistance. One laptop computer and one iPad has have been purchased and marked with Rotary logos. This equipment is made available for the students' use at the Spot. Pizza and other snacks are offered to encourage/entice attendance. The Spot continues the B&G Club's successful incentive program giving students tickets to put into drawings for incentive prizes – the more tickets 'earned' by attendance, the greater the chances for winning. We have ordered and/or purchased gift cards from local businesses (La Sirena Grill for food, Starbucks – very popular) and Amazon as prizes and the Grand Prize is an apple iWatch. These incentives were just ordered – order receipts are attached and detailed payment receipts will be provided when received – expected within 3 weeks.

4. How many non-Rotarians benefited from this project?

Phase One: 248 Students received dictionaries, the additional number of family members benefitted is not known. Additionally, the Dictionaries are purchased from The Dictionary Project, a 501(c)(3) Nonprofit. Income from that organization is also used for literacy projects.

Phase Two: We estimate that 25-50 students/week use The Spot for studying and homework. Many students have become regular attendees and their attendance is encouraged with food and awards for regular attendance. Approximately 200 students are believed to have benefitted from this project, and it encourages younger students and family members to do homework and study.

5. What are the expected long-term community impacts of the project? We still hear from older students about their excitement from receiving their Rotary Dictionary, and many of our Interact Club members know of Rotary because of first being exposed to Rotary's existence by receipt of their dictionary in the 3rd Grade. The Students' families learn of Rotary and its local and international work, and we have received membership and donation inquiries as a result of the distribution.

The Spot is a new program, but we believe its reach will be extensive, as it offers better chances for students for better grades, greater chances at further education and continued participation in the community.

6. If a cooperating organization was involved, what was its role? Phase One: None. Phase Two: The Boys & Girls Club of Laguna Beach provides a qualified Staff Member as the required Adult for the operation of the after-school program and the administration of the daily requirements for the program.

This is a progress report and although the final expenditures, including those listed below have been ordered and committed, final receipts are pending and will be submitted with the final report. Final receipts and evidence of full disbursement is expected in 3-4 weeks max.

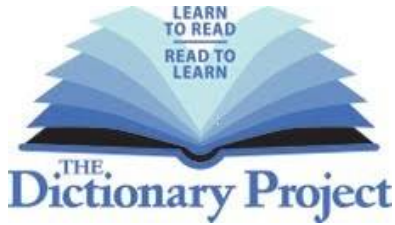

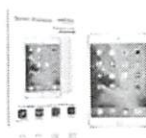

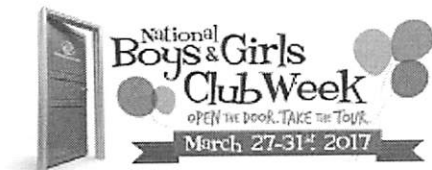
