1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

Purchased and delivered cooking and other kitchen equipment, as well as recreational equipment, to the Orangewood Children & Family Center ("OCFC") to assist in the ongoing education and advancement of the children of OCFC.

2. How many Rotarians participated in the project? Thirteen (13)

3. What did they do? Please give at least two examples.

- (a) purchased cooking and other kitchen equipment, as well as recreational equipment both online and in-person;

4. How many non-Rotarians benefited from this project?

OCFC currently houses approx. 80 needy children who have been removed from their caretakers by police officers or child protective services workers and placed into protective custody, and processes nearly 1,000 such children per year.

5. What are the expected long-term community impacts of the project?

Kitchen goods purchased were of commercial grade to help ensure long life of the equipment. Children at OCFC will be provided with instruction on safe and proper cooking methods by OCFC staff, providing them with "life skills" that will be useful after they leave the facility. Such "life skills" could last the lifetime of the children.

6. If a cooperating organization was involved, what was its role?

OCFC staff were very cooperative and appreciative of Rotary support.
