1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries? During the months of January and February the club in partnership with the Children's Dental Health Clinic provided four (4) days of Oral Health and Nutrition Days at Sorensen Elementary School and Orange Grove School. As a result, **890 students** in 37 classrooms received Oral Health Education and Oral Health Kits and **435 students** (49%) received dental health screenings and fluoride varnish applications. Of those children that were screened, 2% of children were in need of urgent care; 37% were in need of treatment; 61% presented as being in good condition; and 26% may need orthodontic care. The staff at the Children's Dental Clinic will follow-up with resources ensuring that children receive the additional dental care recommended.

2. How many Rotarians participated in the project? Approximately 10

3. What did they do? Please give at least two examples.

Distributed oral health kits to 435 elementary age children. Assisted trainers with oral health presentations.

4. How many non-Rotarians benefited from this project? None

5. What are the expected long-term community impacts of the project?

This year, several classes had 100% participation from each classroom – a significant increase from previous years demonstrating the value of these services. More importantly, children and their families recognize the **importance of oral health** — and its connection to one's overall **health**.

6. If a cooperating organization was involved, what was its role? PIH Health was a partner. They assisted with financial support and will share Rotary's statistics in their health newsletter.
