3. Briefly describe the grant and list any changes that might have occurred (100 words or less).
  - a. The impoverished province of Kien Giang, Vietnam contains few recognizable home shelters, while many families live in tarp structures and mud floor structures. The infrastructure of the current homes are very weak. The roofs are comprised of leaves and plastic tarps that provide minimal protection from the tropical climate. As the rain leaks through, the undeveloped dwelling floors turn into mud. Each constructed house includes a bed with bedding, a bag of rice, two buckets for rainwater, cooking supplies and a clock.
4. Provide a brief (100 words or less) of lessons learned in implementing this grant and how this will improve future grant funded projects:
  - a. This was our first grant submission, so it was definitely a little challenging in terms of following up with the timeline. At the time same there were some valuable lessons learned along the way. The first issue we had encountered during this process was with the Districts Bank fraud alert. It had resulted in the initial grant check bouncing, but we were prepared with additional funds in our account. Secondly, the communication on when the deadline submission was misunderstood. Thankfully, we are still able to submit this grant after the deadline.
