Project Title: Pathways Underpass Public Art - Final Report

Project Description:

1. Briefly describe the project. What was or will be done and where did or will the project activities take place? Explain how the beneficiaries and other community members were or will be involved?

Jackson Wyoming has an extensive bicycle/pedestrian pathway system to separate cyclists and walkers from vehicle traffic. The pathways system includes six public underpasses to allow crossing of up to five lane streets and highways.

The art students of Summit High School and Jackson Hole High School each painted one 80-foot mural for the Highway 89 and Garaman Park Underpasses. The art serves two purposes, one is to enliven a long tunnel and the other is to discourage graffiti and reduce maintenance costs.

The students completed the murals in May and June 2017 under the supervision of high school art teachers, professional painters from Jackson and non-profit directors. The purpose of the Rotary involvement was to support the students with materials and instruction and to introduce the core Rotary themes to students.

Attached are the invoices from two professional artists, art supplies, and other assistance. Also attached are pictures of the art and a 20 second video of the south side mural in the tunnel.

2. How many Rotarians participated in this project? Two Rotarians plus the Board of Jackson Hole Rotary Club who approved the Club's participation. Additionally, two high school Rotarians (Interact) introduced the two high school classes to the Rotary's 6 core areas of focus. Each class chose one area of focus as the theme for their mural.
3. What did or will they do? Please give at least two examples. The Rotarians helped organize and facilitate the project through both personal motivation of the pathways and arts community and arranging approximately 40% of the funding for supplies and technical assistance.
4. How many non-Rotarians benefited from this project? Two groups of persons are beneficiaries. First, the students in Jackson Hole High School and Summit High School who were involved in a public service project while developing their creative skills. Second, several thousand cyclists and pedestrians a year will pass through the tunnel. In addition, by displaying student artwork, we reduce the incidence of graffiti and decrease maintenance costs for the Parks & Recreation department.
5. Who are the beneficiaries and what is or will be the expected long-term community impact of this project? The students and the cyclists and pedestrians who use the pathways system in Jackson. Vehicle drivers benefit by the separation of pedestrians and cyclists from the four lanes of traffic and turning lanes above the tunnel.
6. If a cooperating organization was involved, what was their role? Jackson Hole Public Art is a non-profit organized to develop and fund interesting public art to enhance Jackson Hole and provide opportunities for emerging artists.
