1. Describe the project. What was done, when and where did project activities take place?

ADA compliant picnic tables have been donated. They will be delivered mid to end of May and assembled at the Park. Six picnic benches were refurbished first of May at the President's house. Eagle River Rotary will participate in Park cleanup such as trash pick up, raking, weeding, tree pruning, and planting flowers at locations in the Park from the end of April into June. Eagle River Rotary through its current President will continue as member of the Chief Alex Park working committee over the next year.

2. How many people benefited from this project? Many in Eagle River youth and community. It's a neighborhood park.

As a neighborhood park the youth, the neighborhood and the community at large will benefit. Eagle River Rotary's involvement is part of a community effort involving the Chamber of Commerce, the Chugiak Eagle River Foundation, Anchorage Parks and Recreation, Anchorage Youth Academy, Eagle River Garden Club, Eklutna Inc. and the Boy Scout Troop 293 performs weekly Park maintenance and cleanup during the summer months. We, as part of this group, have provided a clean, convenient and usable park space in Eagle River.

The Garden Club is organizing the flower planting. Eklutna has provided funding by matching Eagle River Rotary's District Grant. Boy Scout Troop 293 works the Park during the summer months.
