1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

Thanksgiving Food Drive

We distribute complete Thanksgiving dinners to San Juan Capistrano families in need as well as Marine families in need at Camp Pendleton.

Santa's Visit

The club reaches out to 6 local schools. The event provides toys to between 500 - 600 kids. Event Day: gates open at 9:00 am. Children are treated to activities such as cookie decorating, holiday crafts, face painting etc. from 9:00 am – 12:00 pm. Mr. and Mrs. Santa arrive via Orange County Fire Authority Engine from our local Station #7 and present each child with an age appropriate gift.

Thanksgiving Food Drive:

- Collect groceries from a wish list handed out to shoppers at 4 different local grocery stores.
- Keep a tally of items so at the end of the day we can buy items that we are missing to be able to have a complete dinner.
- Help drive items to distributions point, divide groceries, fill boxes and distribute to families.

Santa's Visit:

- Volunteers assist with Toy distribution, including Spanish/English translation.
- Secure supplies and operate the children's activities including cookie decorating, face painting and holiday crafts.
- Decorate the Multipurpose Room at Marco Forster Middle School (MFMS) for Mr. and Mrs.
 Santa on stage and entry way.
- 4. How many non-Rotarians benefited from this project?

Thanksgiving Food Drive: 80-100 Needy families and Marine Families Santa Visit- 500-600 Kids

5. What are the expected long-term community impacts of the project?

Thanksgiving Food Drive: The families would not have a traditional Thanksgiving dinner with their families. It is very much appreciated by all who receive the 'complete' dinner.

Santa's Visit: The children come from low economic status and if we did not do this many children would not receive a toy for Christmas; enjoy a visit with Santa or have an opportunity to have a great Holiday Party. It is a wonderful community outreach.

6. If a cooperating organization was involved, what was its role?

INTERACT KIDS from Capo Valley HS and SJH HS work at supermarkets collecting food for the Food Drive and provide activities for children at Santa's Visit as well as assist with gift distribution. Marco Forster Middle School P.A.L. kids wrap gifts and assist with gift distribution for Santa's Visit and San Juan Elementary School kids decorate the boxes for the Thanksgiving meals to be delivered. These kids benefit by getting the opportunity to help their fellow students and support their community. They are wonderful and provide us support on ALL aspect of these events. It runs smoothly because of their support.
