Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries? For several years Garden Grove Rotary has been actively placing life-saving Automated External Defibrillators (AED's) in and around public places in our community. We have so far placed these units in the Acacia Adult Day Care Center, the Garden Grove Community Gymnasium, Kiwanisland Park, the Shakespeare Festival Amphitheatre, the Gem Theater, the community Senior Center, both locations of the Boy's and Girl's Club and this year we placed an AED with each of the three local Little League Baseball Organizations. 2. How many Rotarians participated in the project? All 3. What did they do? Please give at least two examples. Dr. Bill Annan and myself originated the program, have performed all the research as well as contacting the various local and state emergency and health care agencies for approval. We also researched all the various manufacturers of these AED's so as to determine the best units for our needs. In addition we make the discretionary determinations as to where these units will be publicly placed to make the most impact upon public safety. We then make the connections with the recipient organizations and coordinate their training and certifications with the Fire Department. We have also set up joint training sessions with our other Rotarian members and their families in the use of these units and in cardio-pulmonary resuscitation. While the administration of the Public Access to Defibrillators (PAD) program is limited to Dr. Annan, a retired physician and myself, a retired fireman and paramedic, all of the members have at one time or another been involved in either the events surrounding the delivery of the AED's to the various recipient groups and organizations, or in the actual group CPR & AED training that is provided to the individuals of whom will be taking possession of and maintaining these units once we award them to the various recipient groups and organizations. Entire 4. How many non-Rotarians benefited from this project? Community 5. What are the expected long-term community impacts of the project? We are working towards placing as many of these life saving devices in and around the community as we can. Sudden cardiac arrest happens approx 1000 times a day in the U.S. and these AED'S are proven to save lives when applied to the victims within 4-6 minutes following arrest. We would like to become, like Seattle was in the 80's with the implementation of their comprehensive city wide citizen trained CPR program, the safest place in the country to suffer a cardiac arrest in.

6. If a cooperating organization was involved, what was its role? All three Little League Organizations were involved in both the receipt of the AEDS as well as participating in a joint CPR/AED training session. The training was provided to insure that several members from all three recipient organizations are trained in cardio-pulmonary resuscitation and Automated External Defibrillator use and will be ready to act if and when the situation arises.
