Project Description

1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

Camp Enterprise took place April 10-12 at the YMCA Camp Oakes in Big Bear, CA. 57 high school juniors from the LBUSD ended up attending with over 20 club Rotarians serving as mentors. Students were divided into teams and engaged in team building exercises, heard speakers from various professions, and developed a business plan. Each team presented their business plan and one team's plan was selected as the winner. The purpose of the Camp is for students to learn how entrepreneurship is created, how to work in teams, and how to develop individual self confidence.

2. How many Rotarians participated in the project? 88

3. What did they do? Please give at least two examples.
20 club Rotarians attended the Camp and served as mentors, speakers, facilitators. 40 club members donated money specifically for the Camp. 28 members served on the planning committee.

4. How many non-Rotarians benefited from this project? 57 +

5. What are the expected long-term community impacts of the project?
The selected students are not the normal class leaders but show potential for advance education and professional careers. Some of the students do not necessarily fall into standard at risk categories, but do not come from an encouraging home environment. The Camp is intended to increase a student's awareness of what he/she might be capable of, and to teach them the potential of what is available in the free enterprise system.

6. If a cooperating organization was involved, what was its role?
YMCA provided camp facility and counselors. LBUSD counselors and teachers were integral to student recruitment and support of the program.


