Project Title Maintenance of Food Pantry

The shelves were removed from the food pantry, a temporary wall was removed. A permanent wall was built with café doors to separate the two rooms in its place. The pantry was painted, a vinyl wall base was installed, and the floors were stripped and waxed. The shelves were put back into place with new baskets and bins to store the food.

Dave Dykstra – coordinated the work with the Christ Community Church and the Food Pantry. He also worked out the funding from Christ Community Church
Chad DeJager – Chad is the senior pastor at Christ Community Church. He coordinated a meeting with the senior pastor at Bethany Food Pantry, Dave Dykstra, and Lori Olkiewicz (director of the food pantry) to work out the details of the project.

5. What are the expected long-term community impacts of the project? By refinishing the pantry and putting a permanent wall in place, the air circulation will ensure that the food stays in tact for longer.
