Project Description

1. Describe the project. What was done, when, and where did project activities take place? If this is a progress report, what remains to be done?

My Brother's Keeper New Rochelle has a number of programs and projects designed to promote literacy for lowincome children and families throughout New Rochelle. The Rotary Club grant supported two of these literacy projects in particular: MBKNewRo's **Barbershop Reading Program** and its launch of the community collaboration around **Pop-up Libraries**. The grant helped MBKNewRo purchase books and bins for its Barbershop Reading Program, which encompasses 52 barbershops, beauty salons, nail salons and laundromats in New Rochelle. Rotary Club member Barbara Crane spearheaded a rejuvenation of the Barbershop Reading Program by gathering volunteers to replenish the books and bins in dozens of these establishments. She implemented two delivery cycles between September 2018 and May 2019, delivering about 15-20 children's books to each of the participating establishments. Barbara also updated the list of establishments participating in the program and listed contact information and specifications unique to each location. Barbara and MBKNewRo leaders also received hundreds of donated books from contacts at Random House and Scholastic as well as from individuals and Friends of the NR Public Library and from library employee Barbara Davis. These donations and volunteer hours helped MBKNewRo save hundreds of dollars and weeks of employee time. More than \$400 in funds through the grant paid for the purchase of 200 additional books as well as dozens of the bins in which the books were displayed.

In 2018-2019, MBKNewRo collaborated with the New Rochelle Council on the Arts to launch a community effort to place customized books kiosks from the Little Free Library organization throughout neighborhoods in New Rochelle. The New Rochelle Public Library and New Ro's Parks and Rec Department participated in this community collaboration. The New Rochelle Council on the Arts commissioned seven artists to customize each book kiosk while MBKNewRo paid more than \$2,100 to the Little Free Library organization for the untouched kiosks. There are currently 6 artist-designed kiosks installed or ready to be installed in parks throughout the City. These Pop-up libraries have already been installed at Huguenot Park, Lincoln Park, the Ward Acres Dog Park and Hudson Park. Two more kiosks are set to be installed across from City Hall at the bus stop island on North Avenue and in front of Columbus Elementary School. A special double-wide kiosk created by world-famous 3D pop artist Charles Fazzino will be installed at Montefiore Medical Center. Funds from the Rotary Club grant will offset more than half of the \$2,100 cost of these kiosks that MBKNewRo covered.

2. How many people benefited from this project?

If 15 children read or took home one or more books from each delivery to a barbershop or beauty salon, then 1,500 children and their families would have benefitted, although the number is likely far higher. In addition, thousands of New Rochelle residents will have access to the books stocked in the seven artist-designed kiosks.

3. Who were the beneficiaries, how were they impacted by this project, and what humanitarian need was met?

The beneficiaries were largely underprivileged children and their families living in New Rochelle. The two MBKNewRo literacy projects supported by the Rotary Club grant are intended to promote a love of reading and provide increased exposure to good quality literature. These projects also benefit the thousands of students living in New Rochelle for whom English is a second language.

5. What did they do? Please give at least two examples, not including financial support provided to the project.

One Rotary Club member, Barbara Crane, devoted many hours to organizing the purchase and labelling of the bins used in the Barbershop Reading Program, picking up and storing books, recruiting other community volunteers, making the actual deliveries to the shops, and keeping records. Other members of the Club participated through their financial matching of the District grant.

6. If a cooperating organization was involved, what was its role?

The main cooperating organization was My Brother's Keeper of New Rochelle, a joint initiative of the City of New Rochelle and the New Rochelle School District. http://www.mbknewro.com/ MBKNewRo conceived the Barbershop Reading Program in 2016 and had initiated book deliveries to barbershops and beauty salons before the Rotary stepped in with the grant and a member's significant volunteer time. The Rotary Club volunteer was able to rejuvenate and organize the Barbershop Reading Program significantly. Similarly, the Pop-up Libraries program was underway before the Rotary stepped in to help cover the cost of the kiosks and supply books. The New Rochelle Public Library was also a cooperating organization, and the fiscal agent for MBKNewRo is the City of New Rochelle Youth Bureau. As noted above, other agencies and organizations have also participated in the Pop-Up Library initiative.
