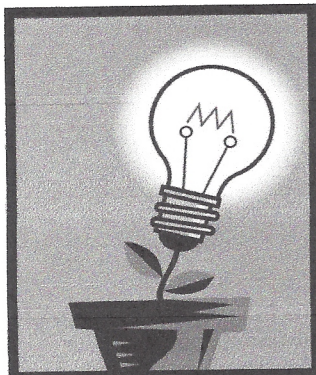
WHICH TOWN/COMMUNITY WILL THE GRANT SERVE?
