- 3. Briefly describe your project (who did what, when and where did project activities take place?) in 100 words or less. Eighty-one low-income fifth and sixth grade students attending Garfield, Grace Jordan, and Koelsch Elementary Schools, participated in nine leadership classes and one community service project. School closures, associated with the COVID19 pandemic, resulted in the cancelation of four leadership classes, one community service project and the Leadership Camp. Because of these changes, only \$2,568 from the Rotary Foundation matching grant was used, leaving us with a surplus of \$6,949. Most (\$4,350) of this surplus is associated with the cancelation of the camp. The surplus funds were redirected to purchase Home Learning Kits for 1,250 low income students. The kits were designed by school teachers to include items that would facilitate virtual learning for students whose homes lack these resources.
- 4. In one brief sentence: who were the beneficiaries of the grant activities and how many of them were there? By the end of the first semester, there was a 72% reduction in disciplinary instances among the 81 low-income students participating at the three schools and over 80% of the students, improved their grades or maintained GPAs > 3.5. 1,250 low income students received Home Learning Kits.

#### **Rotarians:**

- Led group discussions where students described what they were learning and how they
  were using their new skills.
- Sponsored Everyday Leadership at one of the Title I schools.
- Facilitated cooperation among the five organizations participating in this effort,
- Assisted two of the schools in implementing "Buddy Benches"
- Participated in program planning;
- Joined the students in completing community service projects.
- 6. If a cooperating organization(s) other than the beneficiary was involved, what was its role?

- **Teachers and counselors** from participating schools served as lead instructors. **Teachers and counselors** also identified items to include in the Home Learning Kits.
- School principals and teachers encouraged student participation and monitored results.
- The Treasure Valley YMCA provided instructors to work with the lead teachers and maintained a curriculum that appealed to the students.
- **Big Brothers and Big Sisters of Southwest Idaho** provided mentors when requested by students and their parents.
- Members of the Rotary Club of Boise Metro worked with the students and instructors at Garfield Elementary School.
