Project Title: Clean Water Initiative Crow Creek

Project Description:

1. Briefly describe the project. What was done and where did the project activities take place? Explain how the beneficiaries and other community members were involved?

The Rotary Club of Cheyenne in partnership with the Laramie Country Conservancy District (LCCD), Crow Creek Revival (CCR) with its local sponsors and Frog Creek Partners, LLC expanded the clean water project to purchase, install and maintain four additional Gutter Bins as part of phase 2 of our clean water commitment to help prevent future contamination of Crow Creek as it passes through Cheyenne, Wyoming.

With Phase 2 – this project – we've installed three additional Gutter Bins in the downtown Cheyenne area of Crow Creek, as well as one adjacent to the Boys and Girls Club of Cheyenne.

As we successfully reduce pollutants that seep into Crow Creek by our stormwater system, we benefit water quality both in Cheyenne and all areas downstream of Cheyenne.

- 2. How many Rotarians participated in this project? Approximately 5 (4 from Cheyenne plus 1 from Sheridan who owns Frog Creek Partners).
- 3. What did they do? Please give at least two examples. Rotarians organized the purchase and installation of GutterBins and promoted the benefits especially by the Rotarian also serving as the executive director of the Boys and Girls Club of Cheyenne. Rotarians are also involved in emptying, weighing of pollutants, and disposing on an ongoing basis.

- 4. How many non-Rotarians benefited from this project? Future generations of Cheyenne and Laramie County citizens and communities downstream.
- 5. Who are the beneficiaries and what is the expected long-term community impact of this project? Clean water is not only important here in Cheyenne but in the world. As we are successful in reducing the pollutants that seep into Crow Creek by our stormwater system, this technology can then be used in other parts of the country and the world.
- 6. If a cooperating organization was involved, what was their role?

Frog Creek Partners, LLC have developed, manufactured, and installed the GutterBin systems. Crow Creek Revival Project partners are involved in determining placement, coordinating with regulatory and other governmental agencies, installation and ongoing maintenance.
