Progress Report Final Report

- Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?
The Fullerton Arboretum and Botanical Gardens are a focal point of Fullerton, associated with the renowned Green Scene Garden Show. The Arboretum is also well known for being the home of Heritage House and the Orange County Agricultural & Nikkei Heritage Museum. The Arboretum Nature Center offers an educational experience for children and also serves as the Arboretum's Visitor Information Center. It had not been remodeled in 30 years, and the building, fixtures and display shelves were in need of repairs and maintenance; and the furniture, exhibits and displays were worn and dated. The Fullerton Sunrise Rotarians spent two weekends (and several days in between) dismantling and demolishing the existing fixtures at the Nature Center and then painting and renovating and installing new fixtures and displays. This project benefited the children of Fullerton as well as the local community who use the Arboretum.
- How many Rotarians participated in the project? Ten Rotarians actively participated in the remodeling and a large percentage of Rotarians and their spouses assisted with providing refreshments for the working Rotarians, purchasing and delivering supplies and equipment, and representing the club at the Nature Center's Grand Reopening.
- What did they do? Please give at least two examples. The Rotarians spent two weekends dismantling and demolishing the existing shelves and fixtures, stripping, sanding and painting the building, and installing new fixtures and display cases.
- How many non-Rotarians benefited from this project? Fullerton, CA has a population of 137,624 and includes 15 public elementary schools, 2 public K-8 schools, 3 junior high schools, 5 public high schools and 5 universities and colleges. The project benefited the residents of the city of Fullerton in general and the elementary and K-8 school students and Cal State Fullerton students in particular.
- What are the expected long-term community impacts of the project? The Arboretum hosts many school field trips each week, and offers educational classes to the children. The revitalized Nature Center will enhance the children's experience and entice them to explore the Arboretum and enroll in the many classes offered. Serving as the information Center, the Nature Center is the first stop for visitors to the Arboretum and is important in creating a positive first impression and enticing visitors to return.
- If a cooperating organization was involved, what was its role? Two organizations, the Phelps Foundation and the Friends of the Fullerton Arboretum both contributed funds towards the revitalization of the Nature Center.

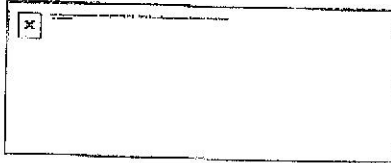

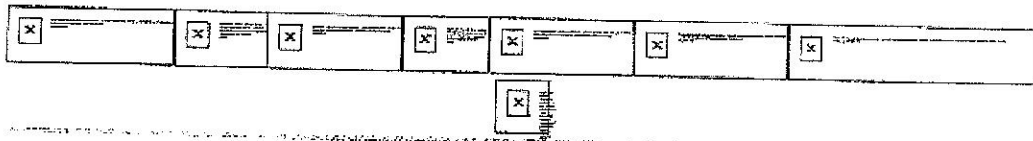

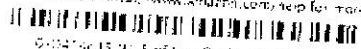
