

The scholarship is renewable annually for three more years, provided that the student maintains</u> <u>acceptable grades throughout the four-year period</u>
- 2. How many Rotarians participated in the project? Five
- 3. What did they do? Please give at least 2 examples. <u>The club's scholarship committee established the</u> <u>scholarship application, made it available to the schools, and selected the recipient. It further reviewed the</u> <u>annual academic progress of second and third year students.</u>
- 4. How many non-Rotarians benefitted from this project? <u>Three. One new student was selected this year, last</u> year's student received her second year's scholarship, and the prior year's student received his second and third year payment.
