- 2. Briefly describe the project. What was done and where did the project activities take place? Explain how the beneficiaries and other community members were involved?

In an agreement with Wyoming Work Warehouse in Gillette, Wyoming, Energy Rotary Club and the Campbell County School District provided winter boots to forty-five children of the county. Mainly elementary school children are involved, but high school and junior high school age students are more than welcome to request a pair of boots. The project was conducted by the Administrative Assistant to the Deputy Superintendent of Campbell County School Districe and the Chair of the Community Service Committee of Gillette Energy Rotary (Tracy Peterson and Jaelene Wterhollon).. The administrative assistant prepared vouchers to be sent to the schools, when requested by the various school gounselors. Schools were notified early in the fall that the funds were available for their students. Unfortunately, we had a very warm winter and along with the COVID 19 issues, many fewer students requested boots. We tried picking the boots up at Wyoming Work Warehouse and delivering them to the schools, ourselves, so that the students or their parents wouldn't have to physically pick them up. In spite of that activity, we only awarded forty-five pairs of boots.

The next step was to send out a survey to the school counselors, asking three questions:

- In the past when we gathered tge suzes neeed for individual students from counselors, The Rotary would pick up and deliver to schools, did you deliver boots to all the students in need?

The entire club, as well as the board, approved the writing of the grant proposal for the project. Four to five board members delivered boots to the schools after picking them up from Wyoming Work Warehouse

 - a. The Chair of the Community Service Committee (Jaelene) met with the owner of Wyoming Work Warehouse, (Tony) to address the distribution of the boots, and the situation where the parents were reluctant to actually appear in person to pick up the boots. When it wwas discovered that only 45 pairs of boots had een requested and delivered, they decided to order additional boots for nest year or to give the Rotary Club a "line of credit".
 - b. School district personel and Rotary members met to plan the best was to get the boots to the students.
- 5. How many non-Rotarians benefited from this project? ____The students and the parents of the community who recieved the boots.____
- 6. Who are the beneficiaries and what is the expected long-term community impact of this project?

The project actually benefits the entire community o aid in controling the health of the children/students of thirteen elementary schools, two junior high schools and three high schools.

Forty-five students were able to wear snow boots to school throughtout the winter and were able to play outside.

Ultimately, the health and well-being of the children is a benefit to the studentss, their parents and the community.

Campbell County School District and Wyoming Work Warehouse partnered with Gillette Energy Rotary to provide snow boots to children/students of the community.

At approximately \$30.00/pair for the boots, we will be able to provide approximately 48 students with snow boots in 2021-2022.
