We donated \$500 to James R. Jordan Foundation's Read with Me Day. The foundation used our donation to purchase children's books for students. Books were selected by staff at Sherman School of Excellence. The actual program was held virtually on November 20, 2020. Volunteers read to students and discussed the books that were read. The beneficiaries were Pre-K to third grade students attending the school and their classroom teachers.

We met virtually with staff from Sherman School of Excellence to select the books to be read. Twelve club members read the books to the students and followed up by asking students about the books that were read.
