It is mutually agreed between **Anchorage Rotary Club** and Premier Alaska Tours Inc. (Premier) that Premier will supply motorcoach charter service as outlined by the terms of this agreement as follows:

1. Premier will provide transportation for **Anchorage Rotary Club** group within Alaska in September.
2. Premier will provide an English-Speaking driver on stated itinerary.
3. Itinerary and driver hours allocated for motorcoach charter is as follows. **NOTE: 48-hour notice is required for any changes to stated itinerary.**

4. **Rate** for services is \$1,000.00 per coach. Note that rate does not include admission to attractions. Rate is for stated itinerary and hours allocated to this itinerary. Additional hours will be billed at \$200/hr.
5. **Driver gratuity** is not included.
6. Note that rate does **not** include admission to any State or National Parks. Often these road-side stops incur an additional fee **per coach**.

7. **Cancellation** of charters may occur up to 31 days prior to departure without penalty. Inside 30 days, **Anchorage Rotary Club** guarantees payment of the following cancellation penalties:  
30-1 days prior to service = 100% of total charter rate
8. **Payment** of charter will be made in full at 30 days prior to the date of service.
9. **Waiver of Liability** The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is reported to be contagious. The state of medical knowledge is evolving, but the virus is believed to spread from person-to-person contact and possibly by contact with contaminated surfaces and objects or in the air. 10. **ASSUMPTION OF RISK.** -- I have read and understood the above warning concerning COVID-19. I hereby choose to accept the risk of contracting COVID-19 for myself and/or my group to utilize Premier Alaska Tours' services and enter Premier Alaska Tours' premises.
11. Premier Alaska is committed to respecting the health measures recommended by the government authorities in order to prevent contagion of the virus.
12. Premier Alaska Tours Inc. reserves the right to alter or cancel motorcoach charter services based on conditions such as freezing rain, excessive snow, road closures, or other acts of God, which would cause a disruption in services or affect the safety of the passengers and/or equipment.
13. Premier Alaska Tours, Inc. reserves the right to add a fuel surcharge onto all motorcoach charters.
