MARCH 9, 2024 AND OCTOBER 14, 2023. ELEMENTARY SCHOOL STUDENTS FOR THE DENTAL CLINIC. ELEMENTARY SCHOOL STUDENTS AND THEIR PARENTS FOR THE EYE CLINIC. All benefited but 218 children had eye exams and 124 children had Dental exams.

Acted as Assistances for the Eye Clinic, conducted testing/ exams and fit glasses on over 200 students and parents. Painted the school. Helped manage registering and moving the kids and the parents between the dental and eye clinic. Helped the dentist conduct exams, manage patient flow, etc.

4. How many non-Rotarians benefited from this project? 342 locals. 35 people were referred for further eye exams.

Kids who can see do better in school, Kids who have healthy mouths/teeth means they will attend school and their parents do not have to miss work to care for them. If your can see you are more likely to work.if you are healthy you are more likely to attend school. This means more individuals can become independent and productive members of their community.


