Project Title: Santa's Workshop

Project Description: During Powell's Downtown Christmas Festival, held on December 2, Rotarians provide a Christmas craft workshop for community children. Rotarians, with the help of community and High School volunteers, provide guidance and material for local children on how to construct Christmas crafts that they can take home for the Holidays. Additionally, we have a face painting booth provided by a local church and a cookie decorating room. The funds will be utilized to purchase 300 cookies, frosting and craft materials to include glitter, fast dry glue, paper bags, crayons, slime material, colored paper, face painting supplies, cotton for Santa beards and candy sprinkles to list a few.

- 2. Briefly describe the project. What was done and where did the project activities take place? Explain how the beneficiaries and other community members were involved?

Our Communities Christmas Fest takes place around December 2nd of each year in downtown Powell. There is a community center, Plaza Diane, that hosts an enchanted forest, middle school choir and choir club members singing Christmas carols, dancing cloggers and a visit from Santa. We hold our Club's Santa's Workshop along with these activities followed by a Community Lighted parade.

Rotarians, with the help of community and High School volunteers, provide guidance and material for local children on how to construct Christmas crafts that they can take home for the Holidays. Additionally, we have a face painting booth provided by a local church and a cookie decorating room.

Our event was held at the Powell Commons, a local downtown events center.

We had 10 High School FFA, 4 High School Cheerleaders and a few additional student and community volunteers to help with setup, and the kids crafts and take down.

A local church provided face painting for the kids.

We had 261 kids participate in the crafts construction. In all, more than 350 people attended Santa's Workshop.

We had two committee chairmen that coordinated the project. They put together a budget and ordered all the necessary craft material purchases. Some got volunteers to sign-up to help. One ordered 300 cookies and icing. One hauled all materials utilized for the project. All participated in set-up for the event and craft instruction and all helped in tear down and clean-up.

How many non-Rotarians benefited from this project?

261 kids, their parents, and grandparents. In all, we believe more than 350 people attended the event.

5. Who are the beneficiaries and what is the expected long-term community impact of this project?

The Rotary Club benefits from good publicity for doing the project. The community and student volunteers become more familiar with Rotary. The students can show on their resumes the volunteer work they do with Civic clubs. This will aid them in possibly receiving scholarships. The community will benefit from being known as a community with a Christmas spirit that provides fun activities to all that want to participate. It makes the community a great place to live. The children that participated had fun and gained some knowledge about Christmas crafts that they can take home.

We would like to get 100% of our Rotary membership working on the project.

A few of our members had to attend a Rotary outbound exchange orientation the weekend of our event. We may look at changing the date next year?

We need to make certain that local families know the event is free.
