	Members of the Loveland Thompson Valley Rotary club shopped and delivered for winter coats to the McKinney-Vento Homeless Education Act liaison, Erica Wooldridge, at the Loveland school district, Erica distributed the coats to the most needy students in time for Christmas 2023. Fifty-two coats were purchased so fifty-one students received coats for this winter.
