Project Description
 Describe the project. What was done, when, and where did project activities take place? If this is a progress report, what remains to be done? This was a cash contribution pledge towards a global grant (GG1524944) for the Scottsbluff/Gering Rotary Club (#1126) in district 5440. Although the project is continuing (currently in phase 2) the estimated completion of the Global Grant is July 2015. The O'Neill Rotary club is finished with their participation.
The following update was submitted by Rtn Joe Schon.
Good morning Dian,
Phase 2 of Kenya Clean Water (GG1524944) in in process now. We will not complete this Phase until July 2015, and I will produce the Final Report after I visit the installed schools during my July trip to Meru, Kenya.
Since GG1524944 was approved and funded by TRF in February 2015, we have installed systems at the following schools: NGIINE SECONDARY CATHOLIC SCHOOL - 140 STUDENTS KAGENE PRI - 100 STUDENTS KANODONE PRI - 374 STUDENTS MICHOGOMONE PRI - 197 STUDENTS
We have just sent funds to Kenya for the next 3 schools: KITHARE PRI MAUA - 1200 STUDENTS THAMARE PRI MAUA - 1400 STUDENTS MWERONGAI PRI MAUA - 618 STUDENTS
AND, we have trained the survey team and received our first Quarterly report on the status of all schools installed in Phase 1. This Survey will be conducted on every school every 4 months (consistent with their tri-mester schedule), for 5 years, as part of documentation and sustainability. The first survey of Phase 2 schools will occur in July 2015.
The total Phase 2 funds expended for these 7 schools and the first survey is: \$29,000.
The Survey Results from Phase 1 schools is that "Everyone is Happy" with access to Clean Filtered Water. Less cases or No Cases of intestinal problems from un-safe water were reported. Test scores from the Ministry of Education Standardized testing showed small improvements at almost all grades in all schools. This survey was conducted on 27 schools installed in Phase 1 (GG1524944) in 2013-2014.
