The Chula Vista Rotary Foundation has a program where bicycles and helmets are distributed to children of all ages, whose families are unable to afford them. This year, for the 36th annual Bike Drive, our goals was to provide 300 bikes and helmets for underprivileged children. We were able to provide a total of 240 bikes and helmets. The reason we did not reach our goal was due to an increased request from the older children for mountain bikes, which are \$23.50 more than the standard bikes. Overall, the program made a huge impact on the community.

With every program, comes an opportunity for reflection, improvement and growth. This year, thanks to Rotary International, we provided 240 bikes and helmets to underprivileged children. The Chula Vista Rotary has been implementing this program for many years and our efforts include coordinated bike distribution plans and volunteer management. This year we moved the warehouse location and welcomed over 60 volunteers to build the bikes. Overall, implementing this grant was seamless and in the future our goal is to meet or exceed our bike distribution numbers.
