Can you imagine having to choose between paying for food and diapers for your young children, or paying for a roof over their heads?

Jessica and Joshua never expected to be in that situation, until Jessica's work hours were drastically cut right around the time that Joshua lost his good job. With their income reduced, they were no longer able to afford their rent. It was with the safety of their three young children in mind that Jessica and Joshua checked their family into the <u>Arlington Life Shelter</u>.

Without rent and bills looming over their heads, Jessica can save each of her paychecks while Joshua works hard to find a full-time job again through the Arlington Life Shelter's employment program. He's also "I don't know if you realize how you are."

# You've Helped Change a Young Life

Shambrea's voice never wavers as she tells the story that led her to the <u>Arlington Life Shelter</u>. For the past two years – ever since she learned her infant daughter, Riele, was disabled — she's lived a life of fear and uncertainty. But now, finally, she's found the stability she and her children needed all along.

In 2012, Shambrea was working a good job and was so proud of her newest baby girl, Riele. Being a single mother of two is never easy, but Shambrea made it work for her daughters.

But when Riele turned one and still wasn't crawling, Shambrea knew something was wrong. The next several months were spent in and out of pediatrician's offices and hospitals. At first, Shambrea says her boss worked with her – but caring for Riele eventually became too demanding, and Shambrea lost her job.

Shambrea received unemployment for a while, which was enough to pay their rent. But when those benefits weren't renewed last December, Shambrea was left with no job, no money and, eventually, nowhere to live. In a situation she'd never planned for, Shambrea didn't know what to do - but thankfully she learned she and her girls would be given a second chance at the Arlington Life Shelter. Shambrea was immediately set up with the resources she needed, including physical therapy for little Riele — a critical intervention at this early stage.

With Riele receiving the care she needs every day, Shambrea is newly energized by the fact that she can start looking for work again. She hopes to find a goodpaying job with benefits within the next few months – and in order to make it a reality, she's seeing her caseworker daily to learn about job hunting and improve her interview skills.

Shambrea has noticed a real improvement in Riele since she's started receiving therapy — and she's overjoyed by the progress.

"You are so greatly appreciated," Shambrea says. "You've given Riele a fair chance in life — without you, none of this would be possible."
