Project Title: EMERGENCY IN-HOUSE PANTRY

**1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?**

Food & provision stocking at two local Family Resource Centers (Buena Clinton Family Resource Center and Magnolia Family Resource Center) both located in Garden Grove, CA. Food and necessities are being purchased by our Rotary Club and delivered to these Centers who, in turn, provide food and emergency provisions to families in stress (evictions, domestic issues, etc). We are stocking two pantries located on-site at these locations. Beneficiaries are well over 1,500 individuals (adults and children) served by these Centers.

**2. How many Rotarians participated in the project?**

Between 2-6 Rotarians participate in this project.

**3. What did they do? Please give at least two examples.**

Rotarians consult with representatives from each organization who collectively construct a "needs list" of provisions that will fill two separately located emergency food pantries. Rotarians purchase the items at local stores and take them to the respective Centers. Rotarians participate in organizing the items purchased and stocking the pantries and putting any "overflow" of items into on-site storage for easy access when the pantries are getting empty. We also place a couple of "well balanced meals" in grocery bags that can be easily distributed to those being served by the pantries.

**4. How many non-Rotarians benefited from this project?**

Well over 1,500 individuals (and 300-400 families) benefit from this project.

**5. What are the expected long-term community impacts of the project?**

The Emergency Food Pantries provide families and individuals in distress with the comfort that they will have food, hygiene and personal care issues taken care of during times of displacement and other domestic emergencies.

**6. If a cooperating organization was involved, what was its role?**

We are assisting two community/family resource centers who work with us to identify food/provision needs and work out the delivery and shelving logistics. We are stocking food pantries used by their constituents in times of need.


