The grant is being used to purchase a portable dental unit for Eastern Idaho Public Health District. The equipment will be taken to schools throughout the district to provide dental services such as cleanings and sealants.

Plans for the project have not changed since the original description was submitted. We have tendered the grant money and funds from our club to Eastern Idaho Public Health District, and they are in the process of obtaining the component parts of the portable dental unit from several different companies. The unit will be put into service this autumn when the school year starts.

After learning about the great need for dental services for children in our area, we explored several different ideas for projects. We had numerous conversations about the options, and several conversations about partnering with other entities. Through this process, we came to understand the value of really listening to people in the community who are experts in a certain field, such as our contact for dental services at Eastern Idaho Public Health District. While Rotarians are excellent at bringing enthusiasm to a project, it benefits us to take guidance from experts in the field on which our project is focused.


