1. Describe your project. What was done, when and where did the project activities take place. If this is a progress report, what remains to be done?

The project will be taking place on June 19th on the campus of the College of Southern Idaho. There will be groups of refugees from eight different parts of the world who have settled here in the Magic Valley that will be participating. Refugees from the following countries will be taking part: Iran, Iraq, Burma, Nepal, Afghanistan, Sudan, Congo and Burundi. The groups will be sharing their culture including food, dress, dance and song.

2. Who were the beneficiaries, how were they impacted, how many were impacted by this project and what humanitarian needs were met?

The benefit to those attending the event will be to learn of cultures of members of the community who have come from different parts of the world and who have come from a different way of life.

3. How many Rotarians participated in the project and what did they do? Please give at least two examples, not including the financial support provided to the project.

We expect to have from 10 to 12 Rotarians who are directly involved in the project. Rotarians will be available to assist in setting up the booths for the event and Rotary will have it's own booth to share with the participating refugees and with the community of the work being done by Rotarians around the valley and around the world.

The CSI Refugee center is in charge of organizing the event. They are recruiting refugees from the community to commit to having booths that will showcase food, clothing, and dance from their native countries.
