### Final Report

**Area of Focus :** Disease prevention and treatment and Community Development

**Background:** The Rotary Clubs of Camp Pendleton and Vista working together with the UCSD Flying Samaritans partnered to provide underserved populations in Ensenada, MX with free health services via a health clinic. The clinic provides medicine and dentistry (when a dentist is available). The clinic is located in Chapultepec (near Ensenada). Services are provided without charge to patients.

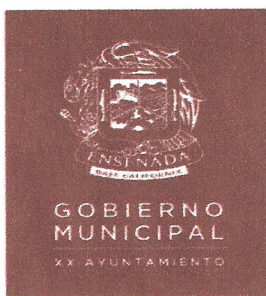
In the past few years the Clubs have refurbished a building so that it could be used as a clinic. It provided fans, motors, dental facilities and miscellaneous items. In addition, it supplied financing for electrical and plumbing services to equip the office. The Flying Samaritans operate in Mexico at the invitation of the Mexican government specifically the DIF (the government office for the development of the family). The clinic is located in a community center near a park and a police station for security.

**Project Description:** Mildew has been noticed around the interior walls of the clinic. While working to resolve the mildew issue contractors and inspectors discovered hidden roof leaks and wood rot. The contractors and healthcare professionals recommended prompt repair because of health issues related to mildew. DIF provided most of the labor. Total cost of the project was \$3,600.

**Final Report:** Rotary District 5340 provided the Rotary Club of Camp Pendleton \$840 for this project. The balance of the funds were provided by the Rotary Club of Vista. Attached is a copy of a paid invoice for paint and materials and labor. It is for 34,371.60 Pesos or \$2,864.30 cents at \$12 pesos to the dollar.
