1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?
 - Four \$1,000 scholarships will be awarded to four Olive Crest Meritorious Students who have graduated from High School and will be able to further their Education.
2. How many Rotarians participated in the project? Approximately 23
3. What did they do? Please give at least two examples.

Eight Rotarians participated on the Scholarship Committee. Four of the members interviewed the Olive Crest Applicants to select the recipients of the scholarships. Four members are available to act as mentors to the recipients. Those Rotarians give time to guide based on the needs of the students. These students come from families that are maligned, beleaguered households. Approximately 15 Rotarians participated in the "Holiday" event put on by the club to present the scholarships to the students. The Rotarians serve the food and insure the families have a fun time in a Holiday atmosphere. For the last 12 years the NIRC puts on a Holiday party inviting those recipients and their entire family to come celebrate. This year there were approximately 45 students and family in attendance. The monies paid for this party were made anonymously and not taken out of club funds or budget.
4. How many non-Rotarians benefited from this project? Approximately 45 the evening of the Holiday event specifically. The families of the students as well as the students themselves benefited greatly as these scholarships were substantial and provided assistance to help these and take some burden off of the family. The community was served in the hopes of giving these students a future and hope to be productive citizens.
5. What are the expected long-term community impacts of the project? The long term impact would be that these students graduate from college and give back to the community. With the positive influence of the NIRC and mentoring program we hope to make these students and families stronger in the community. The community benefits from increasing the level of opportunity and skills that attract investments and new businesses.
6. If a cooperating organization was involved, what was its role? Olive Crest is a 501c3 that helps these students. They were not involved monetarily in this grant.
