Project Title: Eileen Wade "Clothes for Kids" Shopping Event

1. Briefly describe the project. What was done, when and where did project activities take place, and who were the beneficiaries?

The Rotary Club of La Mirada worked with local elementary schools in the Norwalk-La Mirada Unified School District during the Fall of 2015 to identify 51 students in need of new, warm clothing. On December 9, 2015, approximately 65 Rotarians, spouses, family members, friends, Interact students from La Mirada High School, public safety personnel and other community volunteers hosted the needy students during a Holiday Shopping Spree at Marshalls Department Store, which opened its doors early for the special event. Each of the 51 students received approximately \$125 in shoes, jackets, pants, shirts and other personal items they needed. The new, warm clothing was expected to enhance the children's attitude in the classroom through a greater sense of self-confidence and personal comfort. Students were also taken by bus to the La Mirada Activity Center where they received individual presents met with Santa Claus, sang holiday songs and took part in an intergenerational holiday party with a number of senior citizens using the facility.

2. How many Rotarians participated in the project?

Nearly all of the 21 members of the La Mirada Rotary Club were able to participate in the event, which honored the memory of longtime Rotarian Eileen Wade who had championed the event for decades. Numerous spouses, family members, co-workers and friends came along to assist at the event. In addition, several prospective members, Sheriff's deputies, firefighters, City personnel and other community volunteers were on hand. Members of the Interact Club at La Mirada High School also volunteered to assist. In advance of the event, a number of Rotarians participated in event planning and arranging logistics.

3. What did they do? Please give at least two examples.

- Rotary volunteers at the "Clothes for Kids" Shopping event helped young children select clothing items from lists of needed items supplied by their parents.
- Rotarians and other volunteers went through the store's checkout process with each child. The store kept a running tally on the purchases, and the Rotary Club paid for the purchases at the end of the event by check.
- Members and family also purchased and wrapped in advance the gifts distributed to the children at the holiday party.
- Interact Club students participated in the shopping event by shopping with the children.
- Rotarians contacted local schools involved in the project, arranged for City bus transportation and an appearance by Santa Claus, and coordinate refreshments for the holiday party.
- Rotarians also worked at the club's Fireworks Booth during July to raise funds used on club projects throughout the year.

4. How many non-Rotarians benefited from this project?

Approximately 51 needy children and their families benefitted from the Holiday Shopping event at Marshalls. In addition, a number of senior citizens attending programs at the La Mirada Activity Center enjoyed the holiday party held at the facility following the Shopping Event.

This year we were able to accommodate two children with special needs. One of the children was wheelchair bound, and another child was undergoing cancer chemo-therapy.

5. What are the expected long-term community impacts of the project?

This project provides badly needed financial and emotional support to approximately 51 needy children and their families in La Mirada. The program also benefits dozens of senior citizens attending programs at the La Mirada Activity Center. In past years, some of the children involved in the project have received their only holiday presents during the Rotary event. The positive attention and support provided to the students is believed to benefit the students' classroom performance.

Rotary Club of La Mirada's support for this project was well publicized in local newspapers, blogs, newsletters, etc. This publicity serves to enhance the profile of Rotary in the local community, and contributes to a greater sense of momentum for the club. Each year, several individuals living and working in the community have a first encounter with Rotary during this project, and they frequently seek to learn more about Rotary after participating in or reading about the project.

6. If a cooperating organization was involved, what was its role?

The "Clothes for Kids" Shopping event involved the cooperation of the **Norwalk-La Mirada Unified School District** and its local elementary schools to identify needy students and their families. The **Marshall's Department store** opens an hour early exclusively for the Rotary event. The store also donates a breakfast of donuts, milk and coffee for participants (the students did partake of the donuts too) in the event. The **City of La Mirada's Activity Center** is used for an intergenerational holiday party for the needy students and senior citizens using the facility. Staff from the local **Chick-fil-A restaurant** again assisted at the event, including having the company's cow mascot figure attend the holiday party with Santa Claus. The company donated chicken meals, drinks and desserts following the holiday party at the La Mirada Activity Center. The City of La Mirada provided assistance in the form of the appearance by Santa Claus and bus transportation.
