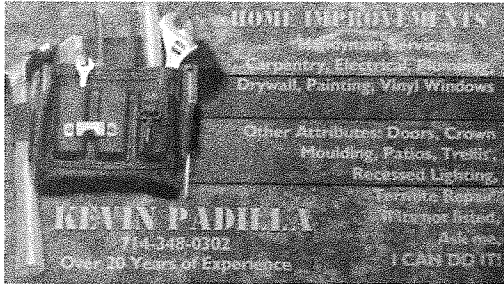

**Progress Made:**

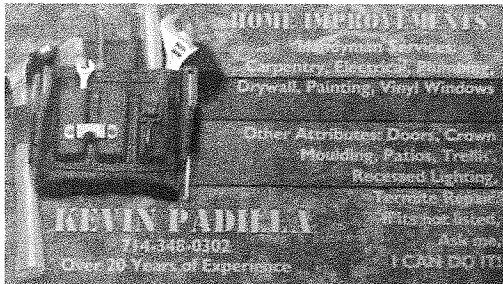
- Demo'd existing appliances, cabinet, fluorescent lighting, kitchen sink, plumbing, etc.

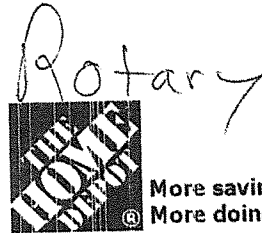

- Removed abandoned conduit next to kitchen exterior door, patched/textured.
- Removed bracket adjacent to door to kitchen, patched/textured.
- Removed and installed 3 new supply register grills.
- Framed down 8ft tall door opening (2), drywalled/taped/floated/textured.
- Installed 6ft double doors with new jamb, doorstop, hinges, casing and hardware.
- Installed 3ft door with new jamb, doorstop, hinges, casing and hardware.
