ABC Scholars Program

Thanks to a grant from the L.A. County Board of Supervisors, the ABC Education Foundation was able to provide over 1,300 fully stocked backpacks for ABC scholars who are low-income and would not have been able to start school with needed school supplies. Attached are the bills for the backpacks and school supplies, along with photos of the community response to the ABC Education Foundation Backpack Stuffing Party, held August 28, 2015 at the Willow Elementary Community Resource Center in Lakewood, California.

Privacy concerns do not allow us to photograph the students who received backpacks, but every school at ABC Unified received an allotment of backpacks, based on needs and requests. The Fedde Community Resource Center also was provided an allotment and parents were able to access those backpacks for their children the first week of school, August 31-September 4, 2015.

Expenses included:

1,020 High Quality, Gender Neutral Backpacks at Nonprofit rate = \$8,017.50

School supplies from major wholesaler at Nonprofit rate = \$5,183.26

Total expenditures = \$13,200.76
