PROJECT OBJECTIVES

The Rotary Foundation approved global grant funding to be used for the following project objectives:

In India, every year close to 20,000 people get affected by varying degrees of Spinal Cord Injury. Spinal cord damage, depending upon the severity of the injury, causes a partial / complete paralysis of the body below the level of injury. These patients need urgent treatment with stabilization surgeries and intense rehabilitation along with attention to allied problems like bowel and bladder incontinence, Gastro intestinal problems, psychological disturbances, etc.

Most of these people belong to the BPL group who just earn enough to meet their daily needs with hardly any savings. Unprecedented instantaneous events like road traffic accidents, fall from height while at work, etc caused this sudden unexpected setback for which they were absolutely unprepared. These victims are usually males in the age group 18 - 45 who are breadwinners of their family. Following this incident, all the resources of the family gets diverted towards the care of the patient with the hope for recovery requiring several compromises by the family members, sometimes to the extent of children having to discontinue school to support the financial needs of the family. This event not only paralyzed the patient, but also paralyzed an entire family!!!

Typically, Spinal Cord Injury not only involves the bread winner but also affects the next bread winner and the other members of the family. The financial drain jeopardizes the lifestyle of the family including children's education and in many cases the children are forced to start earning to sustain the treatment and take the family forward.

This project, provides a holistic rehabilitation program integrating all the needs of the spinal cord injured patients to become independent and perform their daily activities on their own without burdening the family.
