Belpara is a village under the Rotary Club sponsored RCC Dakshindihi. Rotarains have been visiting the area regularly since the RCCC's inception in 1995. The village has a population of approx 5000 and most of the village homes do NOT have sanitary facilities. People defecate in the open, spreading pollution leading water born diseases specially stomach ailments.

Due to ever increasing requirement of water specially for agriculture, the level of under ground water has been steadily going down and ponds & wells go dry in summer, leading to acute shortage of water. View : http://www.youtube.com/watch?v=OoONNAYSKOU

Detail how your project will address these community needs.

The project envisages - installation of 5 Tubewells. Each Tubewell to serve approx 300 people with save Drinking Water, 150 Sanitary Toilets to serve a house hold having approx 6-10 people to defecate hygienically and digging 100 Soak Pits of approx 18 - 21 feet each in ponds where rain water would be collected and be allowed to seep into the under ground dry sand layers to increase the UG Water level and thus ensure availability of water during dry season, specially for irrigation for agriculture towards increase of income.

How were members of the local community involved in planning the project? Does your project align with any current or ongoing local initiatives?

Rotarians have been organizing such projects very successfully in RCC villages viz Dakshindihi & Rampara where the villagers have been involved and Training Seminars have been regularly held on Health & Hygiene and improved Agricultural practices. The RCC run a school & vocational Training Center at Rampara and a Dairy Farm at Dakshindihi. Encouraging planting of fruit trees around their huts, which serve to improve environment, provide nutrition specially to children & income to the housewife.

Once in two months Rotary Club would arrange Training Workshops, put up Posters, distribute Pamphlets in Bengali language. Experts would address Workshops & educate the rural population on Health & Hygiene and ways of keeping a healthy life style at the village.
