

MEMORANDUM OF UNDERSTANDING

Subject:

This MoU is specific to the planning and execution of a project designated as the "Fiji Home Water Filters Project" under Global Grant #GG1419351 in Savusavu, Fiji. The MoU is intended to set forth the responsibilities of each Partner for the benefit of the project as outlined below.

Purpose:

- C. Agree that Rotary will be responsible for all financial management and reporting on expenditures for this project.
- D. Agree to procure materials and equipment necessary for this project
- E. Agree to organize and pay for transport services either by POV or Taxi as needed for Health Officers to attend and participate in all phases of this project that require transport.
- F. Agree to share the final report on the project in the spirit of learning and cooperation and for the betterment of future projects.
- G. Agree to cooperate with the MoH and Savusavu Health Officials in the resolution of any and all issues related to the success of this project.

Rotary Club of Point Loma (San Diego) shall:

- A. Agree to actively participate as lead partners in the planning and successful implementation of this project
- B. Agree to take a leadership role in fundraising to support this project
- C. Agree to participate in equipment procurement, transport and tracking
- D. Agree to document progress on this project
- E. Agree to provide a final report including how the project goals were achieved, project spending and a description of participation of Rotary and MOH partners

Fiji Ministry of Health Savusavu Rural Local Health Authority shall:

- A. Agree to actively participate as "strategic" partners with Rotary in the planning and implementation of this project as outlined by the MoH Vision statement.
- B. Agree to provide staff Health Officers as needed to attend village visits, filter training sessions, and conduct follow up visits as outlined in the Project Plan.
- C. Agree that the participation of MoH officials is at no direct cost to the Rotary Club. (Except transport as outlined above.)
- D. Agree to report to the Rotary Club in writing the findings and results of follow up visits and any issues that may affect the success of this project including filter system operation issues and water-borne illness data
- E. Agree to provide Rotary the data from future, current and past health inventories, studies, and reports conducted by MoH or its agents that are relevant to insuring the success of the project.
- F. Agree to be primary point of contact and liaise with the SDMO medical, Rural Nursing Stations and Village Health Workers for this project.

Modification:

Modifications within the scope of this document shall be made by mutual consent of the parties, by the issuance of a written modification, signed and dated by all parties, and approved by The Rotary Foundation prior to any changes being performed.

Conflict of Interest:

Any real or perceived conflicts of interest must be disclosed to The Rotary Foundation, including any Rotarians serving as paid staff or board of directors for the cooperating organization.
