Project Objectives and Implementation

PROJECT OBJECTIVES

The Rotary Foundation approved global grant funding to be used for the following project objectives:

- 1) To provide funding for 3 VTT teams to travel to Grigore Alexandescu Hospital (GAH) in Bucharest in July, September and October 2016. Approximately 40 Romanian children will be operated during these training visits (20 during the ICHF mission weeks, 10 during the Albany Medical Center mission week and 10 during the SACH mission week). In addition, the recently assembled Romanian pediatric cardiac team will be provided training in the new Heart Center at GAH which is scheduled to be completed prior to the July VTT.
- 2) To fund a cardiology clinic at the new GAH Heart Center for Romanian children with heart disease so that they may be prioritized on a National waiting list for treatment of their heart ailments.
- 3) To fund surgery for 10 Romanian children who will travel from Romania to Wolfson Medical Center in Tel Aviv, Israel for corrective heart surgery while GAH builds its capacity to treat children with heart disease. The cost of surgery and accommodation will be covered through this global grant. The Romanian Rotarians will independently fund the cost of flights for the children and one parent traveling from Romania to Israel.

Objective #1 and #2 were completed successfully.

For Objective #3 - only 9 children were operated at Wolfson Medical Center in Israel. As a result of the training provided the local Romanian team, they began to operate Romanian children with heart disease in Romania. Many parents, upon learning that this was now possible, preferred not to travel to Israel with their ill child but rather to have their child operated in Romania. Therefore a formal change request was submitted and approved to support the local team to perform this last surgery rather than have them travel to Israel.

Have you made progress toward your project objectives?

Describe the progress you've made so far.

October 2016 - 8 children were treated during the first VTT mission and training was provided to the local team.

January 2017 - 11 children were treated during the second VTT mission and training continued from the October mission for the local team.

March 2017 - 5 children were treated during the third and final VTT mission for this grant. The VTT team from SACH continued the training from the January mission as well as worked with those team members who had received additional training at Wolfson Medical Center in Israel. A total of 24 children were treated during 3 VTT mission trips.

An additional 9 children were treated at Wolfson Medical Center in Israel.

The skills of the local healthcare professionals were greatly enhanced through this continuous training. With each training team, the local team was able to take on more responsibility with the patients treated. While still needing some guidance and skills transfer, the visiting teams were able to take a small step backwards with each mission trip. The confidence of the local team to treat children with low complexity heart disease was greatly increased as a result of the training provided through this project.

Additionally, in a country where pediatric cardiac care did not exist prior to this program, it is remarkable that in such a short period of time, children with heart disease are able to be treated in their country of birth. Romanian parents are displaying a level of trust and confidence in their local team to a point where they are choosing to have their children operated in country rather than traveling with them abroad.

Describe how cooperating organizations participated in the project.

Gift of Life International (GOLI) coordinated all efforts between Grigore Alexandrescu Hospital (GAH), Save a Child's Heart Foundation, International Children's Heart Foundation, Albany Medical Center, Gift of Life Romania and host and international Rotary Clubs. Gift of Life International traveled numerous times to Romania to assist with strategic meetings and problem solving through the initial development of this program and throughout the life of this Global Grant. GOLI accompanied Host Rotarians to attend many meetings with the Minister of Health and with the Director of GAH to help ensure adequate staff were in place for training during the training missions, necessary inventory was on hand for each VTT mission and reiterated several times the importance of patient selection and the availability of patients and timing of the patient list. GOLI also accompanied Host Rotarians in several meetings with the staff of GAH to discuss concerns, needs, goals and strategies in the early stages of development of a pediatric cardiac program. Please briefly describe the circumstances for the variance.

Accommodations were over budget due to the SACH team requiring single rooms for all VTT team members whereas other VTT teams shared rooms.

Travel costs were over budget due to the necessity to change all flights for the January VTT team since there was a lack of patients to treat. Additionally, one of the October VTT Team members had a family emergency and needed to have a new ticket issued to return home promptly. Additional trips by the BioMed were needed to ensure all equipment was in good working order for each VTT mission and in particular prior to the first-ever VTT and first-ever pediatric cardiac surgery at GAH. Lastly, additional support was required by Cardiology teams to ensure patients were screened and available for treatment. Other variances are due to currency exchange. We had a surplus in the budget for supplies and meds. This was a result of the following: 1) More donations were received than expected, 2) Few patients were available for treatment than budgeted, 3) GAH also provided many medications and disposables at no charge following the first VTT. This was also unexpected but very welcome and shows initiative on the part of the hospital to develop a program.
