## HARMONY BRIDGE AGREEMENT

This AGREEMENT (this “Agreement”), dated **January 4, 2018**, is by and between **HARMONY BRIDGE LLC**, Minnesota based corporation, Federal Employee ID #47-5157559 and **Kearney Public Schools, 320 W 24th Street, Kearney, NE 68845** (herein referred to as “Sponsor”).

Harmony Bridge and the Sponsor hereby agree as follows:

- 1. General Understanding:** Upon completion of this agreement the designated school district becomes a Harmony Bridge Group and will receive the following:
  - **Exclusive Music Library of 400 books**
  - **Training manual and reference guide**
  - **On-site training (3 days of customized training)**
  - **On-going proactive support from Harmony Bridge LLC**

- 2. Library Exclusivity:** The Harmony Bridge group can be comprised of a single school or a combination of schools including one high school and the middle school(s) (or Jr. High) and elementary schools that feed into that high school. The Harmony Bridge library is NOT to be shared between other high schools and/or their corresponding feeder schools.

Exceptions will be made by Harmony Bridge, LLC on a case-by-case basis (e.g. where one middle school feeds into more than one high school.)

- 3. Additional Materials:** Additional books are available to Harmony Bridge participants at a reduced rate (to be determined).
- 4. Photocopying:** Photocopying is NOT authorized and is STRICTLY prohibited without written consent of Harmony Bridge LLC.


7. **School Responsibility:** As part of this agreement the school(s) agree to annually:
