## **Project Description:**

1. Briefly describe the project. What was done and where did the project activities take place? Explain how the beneficiaries and other community members were involved?

The Kemmerer Rotary Club partnered with the City of Kemmerer to replace the footbridge on the city's popular walking trail located adjacent to the municipal golf course, Little League fields, and kids' fishing pond. The existing wooden footbridge had holes in the surface, was slick on frosty mornings, and users would get splinters from the wooden handrails. City crews removed the wooden bridge, installed a culvert, brought in and packed fill dirt, installed new metal railings, and paved and milled the surface.

A Rotarian who was also the city administrator served as the liaison between the city and Rotary. Rotarians publicized the project and managed the budget. They provided hands-on work by painting the handrails.

- 5. Who are the beneficiaries and what is the expected long-term community impact of this project?

Of three trails in the Kemmerer community, this trail, by far, receives the most use and is kept open year-round. It is frequented by walkers, runners, and cyclists and is a favorite

spot for small children learning to ride bikes. The new footbridge will insure that community members will safely enjoy the trail for years to come.

6. If a cooperating organization was involved, what was their role?

The Kemmerer Rotary Club partnered with the City of Kemmerer and worked closely with the City Administrator and Public Works Director on planning, budgeting and logistical considerations. City personnel and equipment removed the existing bridge, placed the culvert, added the handrails and completed the site work.

The final product is outstanding--safe, attractive, easy to maintain.

13. What did not work well and how would you suggest improving it?

When the grant process for this project was initiated, the Kemmerer Rotary Club had every intention of completing it before the end of the 2017-18 year. Because of changes in the scope of the project and because of standing water at the bridge site, work extended into the 2018-19 Rotary year. This extended timeline would have been difficult to anticipate. Ultimately, the only course of action was to extend the time needed for completion.

14. How was this project publicized?

Regular updates with pictures were posted on the Kemmerer Rotary Club's Facebook page and on the Kemmerer Community FB page. A sign noting that this is a Rotary project has been placed on the bridge.
