Five Rotarians attended the Fountain Valley School District (FVSD) Board Meeting to deliver a check for \$3,000.00 to be used to support the literacy efforts at Tamura Elementary School. Rotarians worked with the school to select and procure the leveled reader kits from the publisher. Rotarians read to the kindergarten and first grade classrooms, demonstrating our long-time commitment to education, specifically literacy.

- 4. How many non-Rotarians benefited from this project? Approximately 105 non-Rotarians benefitted from the project.
- 5. What are the expected long-term community impacts of the project?

The Fountain Valley School District has a major initiative on literacy. Numerous studies have found that literacy continues to the prerequisite skill to improved economic outcomes for students. To this end, FVSD has placed a strong emphasis on ensuring all students read at grade level by the end of third grade. If the district can meet this demand, the future educational, economic, health, and welfare of the these students will extend far beyond the walls of the classroom and impact the overall community, too.


