Project Description:

1. Briefly describe the project. What was done and where did the project activities take place? Explain how the beneficiaries and other community members were involved?

Five Trails Rotary Club partnered with Frog Creek Partners to install 4 Gutter Bins in Casper, WY. 2 of the Gutter Bins were installed on the south side of Casper City Park in downtown Casper and 2 were installed in a high traffic area along 2nd Street in Casper, WY. The purpose of the Gutter Bins is to filter stormwater so that the trash and sediments don't make it to the North Platte River.

2. How many Rotarians participated in this project?

6 members of Casper Five Trails

1 member of Casper Reveille

1 member of Casper Rotary Club

3. What did they do? Please give at least two examples.

Dug trash out of the gutter before the bins were installed and assisted with the installation of the mundus (trash catching) bags. The Club members will assist with the replacement of the mundus bags 4 times per year.

4. How many non-Rotarians benefited from this project? Unknown, since the purpose is to help keep the river clean which benefits everyone downstream and also wildlife.

- 5. Who are the beneficiaries and what is the expected long-term community impact of this project? There are currently 44 million cigarette butts in Casper headed to the river. The gutter bins will filter those along with other trash items such as plastic straws, pop bottles, and sediment. There are 2000 fish per mile in the North Platte above the city of Casper and 800 below the City of Casper, so protecting the river will be beneficial to the fish and wildlife downstream.
- 6. If a cooperating organization was involved, what was their role?

 The City of Casper coordinated with us on the location of the Gutter Bins, since the bins are located on city property.
