  - Provision of holiday gifts to dozens of children in financial need or homeless as identified by the school social workers. This is a long standing project of the Rotary Club of Naperville Sunrise. This year the total Christmas gift package included a total of \$3,467 in Cash and gifts from the Naperville Sunrise Rotary which included the \$1,417 grant funding. Additional gifts and cash donations by the Naperville Sunrise Members totaled \$2,050
- 2. How many Rotarians participated in the project?
  - A minimum of 41 Rotarians participated in the program
- 3. What did they do? Please give at least 2 examples.
  - Provided Cash and Christmas gifts totaling \$2,050
  - Orchestrated the Gift Giving, Collected presents and cash and delivered them to the School foundation for distribution.

  - Approximately 70 non-Rotarian Children received Christmas gifts that they would not have received.
